EDUCATORS: LAST CALL TO APPLY FOR A BRIGHT IDEAS GRANT APPLY BY: FRIDAY, SEPTEMBER 14 2018

STATESVILLE, N.C. – Time is running out for educators to apply for grants up to \$2,000 from EnergyUnited's Bright Ideas program for the 2018-19 school year. **Friday, September 14** is the last day to submit an application for funding for creative, hands-on classroom projects. Last year, EnergyUnited awarded nearly 40 teachers from 11 of the 19 counties they serve with over \$40,000 in Bright Ideas education grants to fund innovative classroom learning projects. Over 12,000 students at schools in Alexander, Cabarrus, Davidson, Davie, Forsyth, Guilford, Iredell, Mecklenburg, Randolph, Rowan and Wilkes counties participated in Bright Ideas projects funded by EnergyUnited.

The grants are available to K-12 teachers from public, public charter, private and Christian schools for innovative projects in any subject. Applications require an outline of the proposed project, a detailed budget and a description of the benefit to students. Applicants are also encouraged to highlight the innovative, creative elements of the project and to proofread carefully. Only applicants that are submitted electronically through the website will be accepted.
