**REMINDER FOR STUDENTS TO APPLY FOR  
SUMMER BASKETBALL CAMP SCHOLARSHIPS**

**STATESVILLE, N.C.** – The deadline is quickly approaching for elementary and middle school students who are enrolled in grades 5, 6 or 7 to apply for a scholarship from EnergyUnited to attend basketball camp this summer.

Each year, EnergyUnited awards two Touchstone Energy Sports Camp Scholarships: one for a young man to attend the Roy Williams Basketball Camp at the University of North Carolina in Chapel Hill, and one for a young woman to attend the Wolfpack Women’s Basketball Camp at N.C. To be eligible, students must be in the fifth, sixth or seventh grade during the 2018-2019 school year and should reside within EnergyUnited’s 19 county service area. Applicants must have permission from a parent or guardian to attend the overnight camp and should plan to provide their own transportation to and from the camp, if selected to attend.
