With Board President Max Walser presiding, the following proceedings were held (action being by unanimous or without dissenting vote or abstention unless otherwise stated):

1. CALL TO ORDER

President Walser called the meeting to order.

2. INVOCATION

Treasurer Craig Black gave the invocation.

3. <u>ROLL CALL</u>

Upon calling the roll, all directors were present. Also present were Chief Executive Officer Thomas Golden, Chief Operating Officer Brett Alkins, Chief Financial Officer Alec Natt, Vice President of Human Resources Pam Britt, Vice President of Energy Services and Corporate Communications Laquisha Parks, Vice President of Information Technology Gaudy Jandron, Vice President of Energy Delivery Steve McCachern, Corporate Attorney Roy McDonald, and Executive Assistant Shamica Butts-Young.

4. <u>NRECA'S NATIONAL SPOKESPERSON AT POWEREXCHANGE, MADELINE</u> <u>HITESHUE</u>

Madeline Hiteshue, NRECA's National Spokesperson at PowerupXchange, who was accompanied by her father, made an inspirational presentation to the board.

6. NOVEMBER POWER SUPPLY REPORT

COO Alkins addressed questions concerning the November Power Supply Report.

7. NOVEMBER WHOLESALE POWER COST ADJUSTMENT REPORTS

CFO Natt and COO Alkins addressed questions concerning the November Wholesale Power Cost Adjustment Reports.

8. <u>LITTLE MOUNTAIN TRANSMISSION LINE EASEMENT ACQUISITION UPDATE</u>

VP McCachern reported that progress is still being made securing easements for the Little Mountain Transmission Line. There are still several property owners who have not signed easements, primarily because they believe their land is worth more than EnergyUnited has offered. EnergyUnited is continuing to work with these property owners, but condemnation is still a possibility. The next major step EnergyUnited takes is to direct its contract attorneys to send demand letters.

9. SERVICE RULES AND REGULATIONS FEE PROPOSAL

VP McCachern presented proposed changes to the Service Rules and Regulations fee schedule and the justification for such charges.

No action was taken on this item.

10. <u>REDLG GRANTS/LOAN PROCESS</u>

COO Alkins presented a review of the U.S. Department of Agriculture Rural Economic Development Loan/Grant process and discussed past and current REDLG projects.

No action was taken on this item.

11. JD POWER YEAREND UPDATE

COO Alkins reported that EnergyUnited's ratings increased significantly all categories measured and EnergyUnited was ranked #5 out of the 145 cooperatives surveyed in overall customer satisfaction.

CEO Golden reported on an accounting error. VP Parks reported on the newly operational Mocksville Kiosk. CFO Natt reported on the status of the 2022 Audit. CFO Natt also reported on the RUS Audit. CEO Golden reported on the status of the Perendale project. CEO Golden also reported on the recent transformer sabotage and internal efforts to ensure the cooperative is taking reasonable efforts to secure its facilities and prepared if required in the event of sabotage. EA Butts-Young presented a review of the director expense reimbursement process and proper completion of reimbursement forms. EA Butts-Young also presented a report of upcoming director training, conferences, and meetings.
