Life Saving Rules

- Do Effective Job Briefings
- Designate an Observer
- Proper use of PPE
- Proper use of Cover-up
- Proper Clearance and Grounding
- Speak Up



Commitment to Zero Life Saving Rules

○ Effective Job Briefings

- Using our Safety Management System to guide through and document process
- Ensure all areas of safety are covered
- Requires interactive participation of all on crew



Commitment to Zero Life Saving Rules

○ Designate an Observer

- Must be qualified
- Only job is to watch employee working on energized equipment or line
- Watching for any hazards or positioning unseen by those performing work.



Commitment to Zero Life Saving Rules

○ Proper Use of PPE

- Hardhat
- Safety Glasses
- Gloves (work and rubber)
- Safety Shoes
- Fall protection
- FR clothing
- Other



Commitment to Zero Life Saving Rules

○ Proper Use of Cover-up

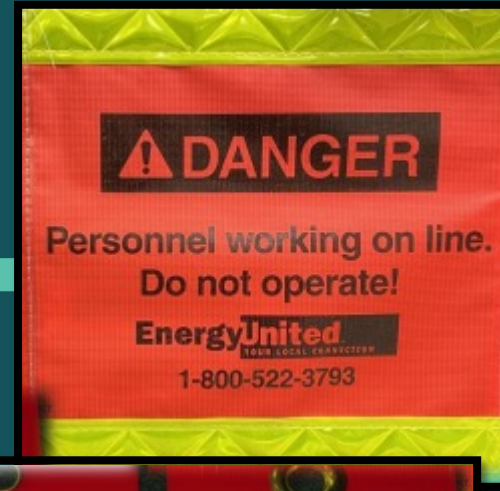
- Rubber hose
- Rubber blanket
- Proper method of installation
- Incidental contact



Commitment to Zero Life Saving Rules

○ Proper Clearance and Grounding

- Only two states
 - Energized and Live
 - Grounded and Dead
- All open points properly tagged
- All affected employees notified
- Dispatch notified



Commitment to Zero Life Saving Rules

○Speak Up

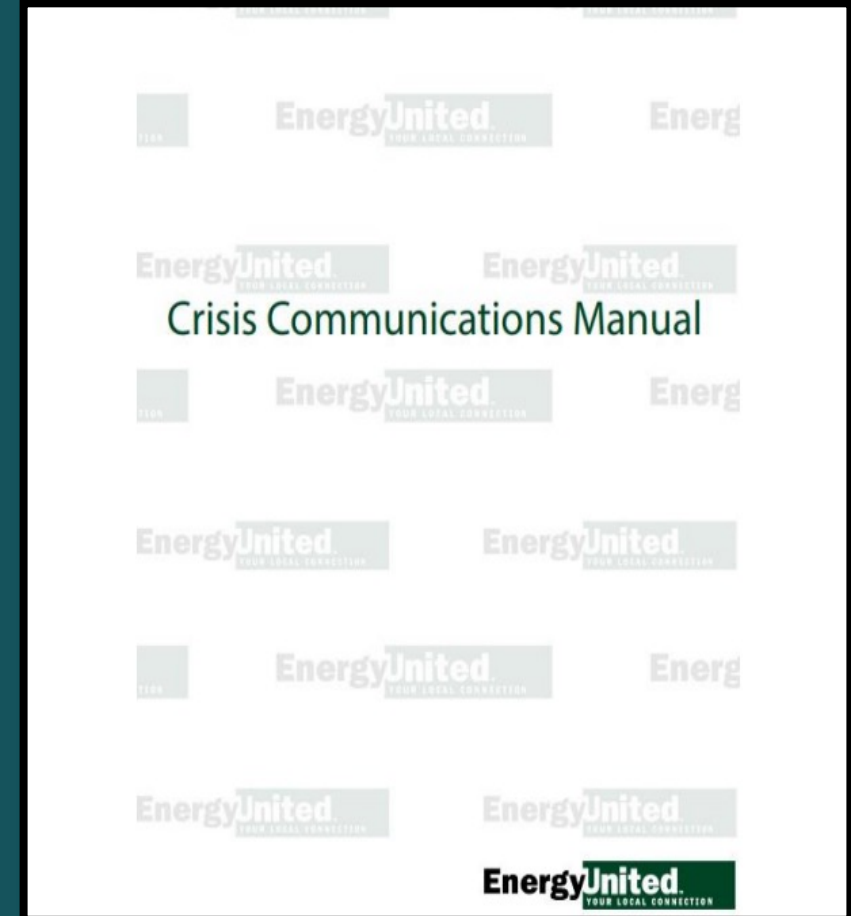
- Encourage questioning attitude
- Learn by asking
- Ensure everyone knows
- Other part of equation = Listen Up



Commitment to Zero

In the event of an Incident Implement:

- Crisis Communications Manual
- Emergency Action Plans
- Incident Reporting and Investigating
