## Operation Round Up: Giving Back to Families in Need

Sometimes, all we need is a guardian angel and a little bit of luck. In the spring of 2015, Shaunte Pittman, a mother of eight children, was desperately in need of funding for safety and health related renovations to her home in Statesville, NC. With just the right amount of luck, Shaunte was able to connect with EnergyUnited Foundation, which provided funds for the renovations, with support from generous members as part of Operation Round Up.



Before EnergyUnited became involved with the restoration project, Shaunte and her husband, Jeffrey, contacted Our Towns Habitat for Humanity about needed renovations to their home. The renovations would help with health related issues that Shaunte and some of her children were having, such as breathing

problems attributed to mold in the house. Habitat helped Shaunte and her family get a plan in place for the construction, but they were missing a key ingredient: the resources to pay for the extensive renovations.

That's when Shaunte found herself at EnergyUnited's Statesville office with her cousin to pay an energy bill. When a customer care representative learned of Shaunte's situation, she encouraged her to apply for a grant from the EnergyUnited Foundation. In November 2015, the nine-member board of the EnergyUnited Foundation approved \$10,000 to pay for the costs of renovations on Shaunte's home.

The funds for this program come directly from EnergyUnited members who contribute to Operation Round Up. Each month, over 65,000 members choose to "round up" their energy bills to the nearest dollar. The excess change is placed into a fund and is then donated to families in need across EnergyUnited's 19-county service area by the EnergyUnited

Foundation board. The goal is to assist community members with bills and expenses that they cannot afford due to a catastrophic health issue, loss of a job, loss of a spouse or other situations that may hinder a person from having the necessary finances to support their family's health and home.

For Shaunte, the \$10,000 from the EnergyUnited Foundation, combined with a \$5,634 gift from Our Towns Habitat for Humanity, was essential to providing a safe home for her family. Renovations to her home included replacing old carpet with laminate floor to eliminate respiratory problems, leveling the floors, repairing the HVAC system, updating the electrical system, replacing a range hood, replacing kitchen cabinets and countertops to remediate mold and repairing

plumbing fixtures in the kitchen and bathrooms to improve the drainage system. The family was also able to replace handrails and steps throughout the house and remove decaying ceiling tile and insulation in one of the bedrooms. Jeremy Bushay, Shaunte's 13-year-old son, recently created a short video to highlight some of the renovations and repairs made to the home. The renovation project has truly been a community effort, and Shaunte and her family have been directly involved from the beginning, going above and beyond the 15 hours of "sweat equity" required by Habitat for Humanity. "They have really put in a lot of time and dedication to make these renovations a reality," said Jamie Hofmeister-Cline, Repair Program Coordinator for Habitat.

"We are so grateful for the help we've been given," said Shaunte during a recent visit to her home. "God knows this assistance really helped us out. We sow seeds when we barely have anything. We are faith driven. We teach our children to

put God first." Shaunte is a hard-working, loving mom to her eight children. She grew up in Manhattan, New York City, and spent time working as a park enforcement patrol officer before relocating to North Carolina with her family in 2010. She is now taking classes at Liberty University in interior design and writing poetry in her spare time. Her husband, Jeffrey, is a gospel singer, songwriter and an ordained minister. Their renovated home creates the perfect backdrop for a family rooted in love, faith and joy.

## Twice in a Lifetime: Austin Story, EnergyUnited's Fastest Lineman



All of EnergyUnited's linemen recently completed a pole top rescue training exercise. As part of the training, each lineman was required to climb a pole and rescue a training mannequin that was hanging from the utility pole. The lineman must then be able to secure the mannequin using clips and ropes,

safely bring it back to the ground and conclude with CPR. The linemen must perform in less than five minutes in order to maintain their certification to work on power lines.

After all linemen at EnergyUnited finished the pole top rescue, our safety team identified the lineman with the fastest time and a runner-up to compete against other North Carolina electric cooperative linemen in the finals in Raleigh, NC. Austin Story, from the Foothills region, is one of EnergyUnited's youngest and fastest linemen and will be representing EnergyUnited, with a winning time of 1:45.60. Levi Fagan, from the Lake Norman region, is runner-up with a time of 2:02.22.

Winning this competition is really exciting for Austin as *it's happened twice in his lifetime*. Austin represented (continued on page 4)

EnergyUnited at the statewide competition in Raleigh in 2014, with a time of 1:50.44, which earned him sixth place. He hopes this time that he will improve his score. While time is one aspect of the competition, Austin made no mistakes with his work skills or rescue techniques, which he plans to do again this year. "I'm very excited and thankful to be going to Raleigh again to compete and to represent EnergyUnited," said Austin. "I feel very honored that I've been given this second chance. I'm tickled to death. It's so surreal to me."

At the upcoming competition, the participants must react to a scenario where a fellow worker is unconscious atop a utility pole. Each competitor must call out to the training mannequin, run to the truck and make a mayday radio call to the dispatch center, grab his tools, put on climbing gear and scale 20 feet up a utility pole.

When he is at the top, he must rig a rope, rescue and lower the training mannequin to the ground safely and perform CPR. This competition pits linemen against the clock and each other as they demonstrate essential lifesaving skills. Each competitor had to win a local competition in order to advance to the championship in our state capital.

The event will be held on the lawn of the North Carolina Electric Cooperatives building in Raleigh on Tuesday, September 27. Best of luck to all linemen, but especially to our own Austin Story!
